

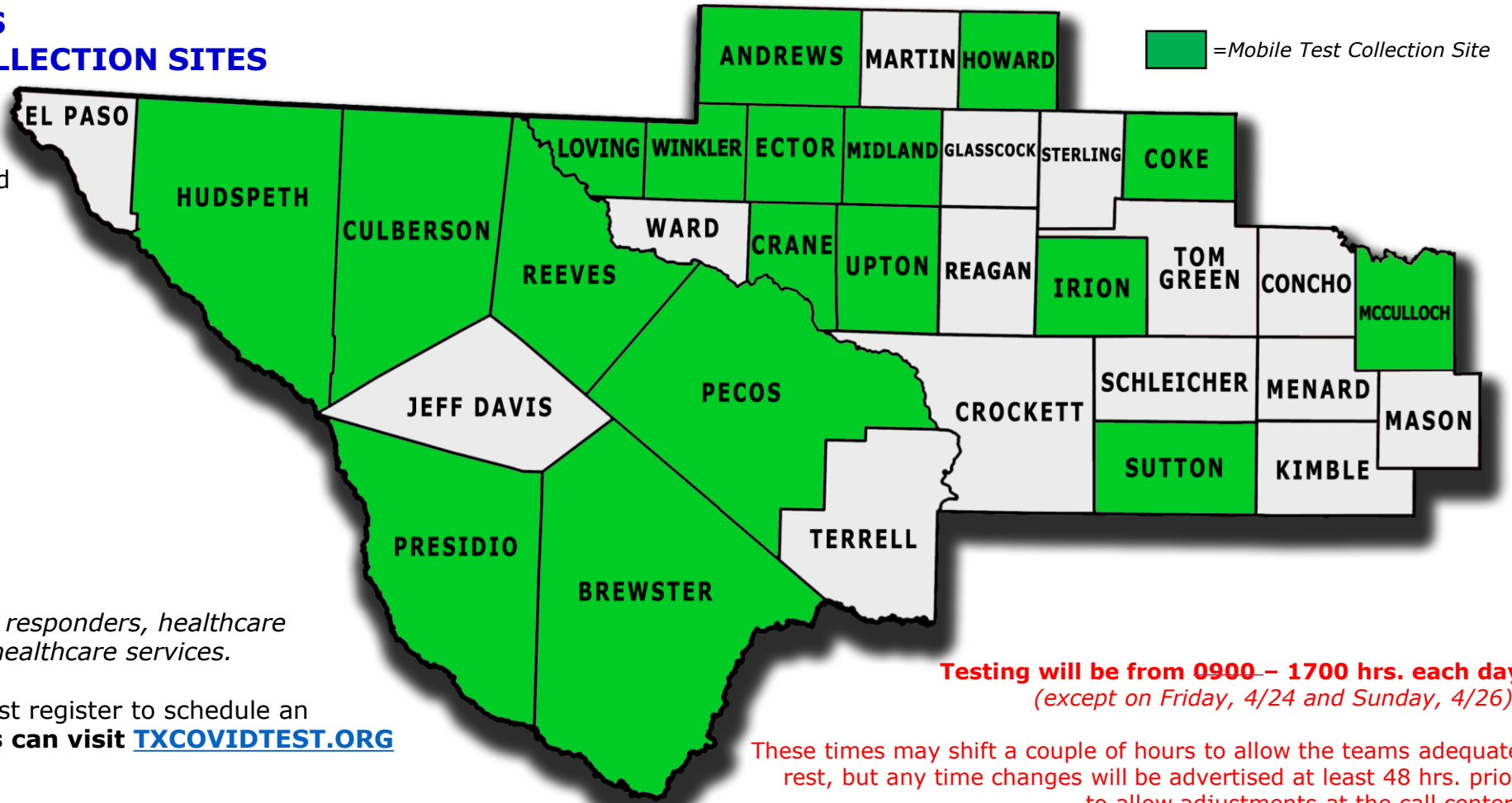
WEST TEXAS COVID-19 MOBILE TEST COLLECTION SITES

To be eligible for testing, residents need to exhibit at least one or more of the COVID-19 symptoms, which include:

- Fever
- Cough
- Fatigue
- Body Aches
- Shortness of Breath
- Sore Throat
- Headaches
- Nausea – vomiting – diarrhea
- Nasal Congestion
- Loss of taste or smell

**Testing is open for asymptomatic first responders, healthcare providers and individuals who provide healthcare services.*

Individuals who are seeking testing must register to schedule an appointment. **To register, individuals can visit TXCOVIDTEST.ORG or CALL 512-883-2400.**



Testing will be from 0900– 1700 hrs. each day
(except on Friday, 4/24 and Sunday, 4/26).

These times may shift a couple of hours to allow the teams adequate rest, but any time changes will be advertised at least 48 hrs. prior to allow adjustments at the call center.
