Key Accomplishments of Reporting Year:

In 2022, Morton Hospital enhanced its focus on initiatives related to our key community benefits priorities, particularly: substance use disorder support, mental health support, improving access to care, unemployment support, and educational advancement and support.

Substance Use Disorder Support:

After opening our new Level IV Inpatient Substance Use Disorder Treatment Unit ("MORCAP") in December of 2021, we expanded our efforts to generate new inpatient referrals to the program by outreaching to key community partners, providers, other hospitals in the region and additional referral sources. Throughout 2022, MORCAP maintained an average daily inpatient census of 10 patients. While the program did attract patients from within the hospital's primary service area, the majority of patients referred to the program came from various other communities within the region and across the state. We also introduced the MORCAP Intensive Outpatient Program ("IOP") in 2022 and held weekly group support programs.

Mental Health Support:

The demand for mental health services grew in 2022, and in response, Morton Hospital added two additional providers to the hospital's Department of Psychiatry and Behavioral Health. The department welcomed Rebekah McHoul, RN, MSN, CNP, and Maura Davis, NP. The hospital also developed and introduced a new Electroconvulsive Therapy (ECT) program accredited by the Department of Mental Health, as an additional treatment option for many types of mental and emotional conditions diagnosed in patients. Lastly, the psychiatry program maintained a commitment to supporting the mental wellbeing of hospital employees by offering drop-in hours specifically for staff.

Improving Access to Care:

Morton Hospital expanded its primary care base with the addition of seven (7) new primary care providers throughout the year. The providers joined practices in Taunton, Raynham and Lakeville. In addition, specialists were added in the areas of medical weight loss and substance use disorder treatment.

Unemployment Support:

Efforts to recruit and employ new staff increased exponentially in 2022. The hospital grew its Human Resources Department, implemented new recruitment initiatives, and hosted a total of 13 hiring events throughout the year. The hospital also facilitated three (3) New Nurse Graduate Programs aimed at giving new graduates the skills, education and hands-on learning to transition into fulltime nursing careers. Six new graduates completed the program.

Educational Advancement & Support:

Our hospital leadership team collaborated with our union and community partners to develop and implement several training and development programs including:

- Sterile Processing Tech Apprenticeship Program
- Phlebotomy Apprenticeship Program
- Radiology Tech Apprenticeship Program
- ED Residency Program
- ICU Residency Program
- MHA Training Program

We also continued multiple internship programs, including a medic internship program with 20-30 students participating annually; nursing preceptor programs in collaboration with multiple schools including Brockton Hospital School of Nursing, Northeastern, Regis, Salve Regina and Massachusetts College of Pharmacy and Health Sciences; and nursing student rotations from BayState College, Laboure College and Bristol Community College.

Additional achievements:

- Continued efforts to encourage staff to be vaccinated against COVID-19, and hosted two staff vaccination clinics in 2022.
- Worked with community partners representing various sectors to successfully post an RFP to the community to support a Mental Health First Aid program and enhance mental health awareness and interventions among youth and disadvantaged populations. Applications were reviewed and a grantee was selected by the Community-Based Health Initiative (CHI) Committee to carry out the proposed interventions.
- Maintained deep involvement within the community, serving on various boards and committees, as well as providing more than \$75,000 in sponsorships and donations to community organizations to support capacity building and other important health and wellness related strategies.
- Finalized our triennial Community Health Needs Assessment in collaboration with outside consultants.

Plans for Next Reporting Year:

Plans for 2023 include:

1. Implement Year 1 of our Community-Based Health Initiative (CHI) through DoN funding to the Boys & Girls Clubs of Metro South to support their strategies aimed at increasing mental health awareness and interventions among youth and disadvantaged populations.

2. Continue to grow our presence in our community and support capacity-building efforts of our community partners through donations and sponsorship opportunities.
3. Further develop our newly-created ED Residency and ICU Residency programs and increase participation in both.
4. Enhance our involvement with key community partners and collaborations whose missions are aligned with our community benefits priorities. This includes expanding our involvement with community-based committees like the Community Crisis Intervention Team.
5. Update our annual Implementation Strategy to incorporate findings and address health and wellness trends identified in our triennial Community Health Needs Assessment, completed in 2021 and finalized in Q1 of 2022.
